



A LETTER FROM MAYOR ARMSTRONG



Dear Haysville Friends and Neighbors,

In the City of Haysville's last Community Newsletter, I told you about some of the projects the City was working on, including our street maintenance program, entryway signage, the addition of bicycle/pedestrian bridges in South Brooke and Peachwood Additions, and construction on the new Haysville Activity Center and Haysville Soccer Complex.

The 2016 street maintenance program is nearly complete. There has been substantial progress on the Haysville Activity Center (see photo below from September 19th) and the bicycle/pedestrian bridges are being installed. Entryway signs have been installed on North Main Street and Broadway; the remaining six signs should be erected by the end of the year. There is always plenty to do in town, but I speak for all employees of the City of Haysville when I say the community's patience during our progress is very much appreciated!

As always, though, I continue to remain focused on the future. The Haysville City Council approved the budget for 2017 on August 8th. The City will be offering the same level of service without any increase to the mill levy. In fact, the mill levy for 2017 is .036 mills lower than it was in the 2016 budget. The City has also entered into an agreement with Haysville School District 261 for the construction of a natatorium. Having the new Activity Center, the Dewey Gunzelman Memorial Pool and the USD 261 Natatorium in one centralized complex will be an exceptional amenity for the citizens of Haysville.

Enhancing quality of life continues to be a key priority for City administration. To that end, the recreation department is steadily increasing their program offerings, both for young people and adults. Paint the Night, a new event just for adults, is one such example. Scheduled for November 18th at the Community Building, this wine and paint party should be an evening filled with fun. Haysville Recreation, in conjunction with Haysville Forward, is bringing back the Gobble Wobble Run/Walk, which is open to athletes of all ages and abilities. This year's event, on November 5th, will still be officially timed, but will feature both an 8K and a 5K.

Another priority in Haysville is maintaining and improving infrastructure. As Haysville continues to grow, expansions to our water delivery system become necessary. Work is currently being done on south Meridian to connect two waterlines, which will create a loop system. This should ensure consistent service delivery and increase fire flows. YOU SHOULD KNOW ABOUT...

HAYSVILLE ZONING & PLANNING CODE

ART. 5 SEC. 500 B(2b)

Portions of this article read: "No off-street parking shall be permitted in front yards, other than established hard surface driveways. Off-street parking in back and side yards shall be permitted on an all-weather surface. Off-street parking access path shall be an all-weather surface the width of the vehicle, and shall extend from the accessory off-street parking to the hard surface driveway or easement. All off-street parking shall not infringe on any road right-of-way or easement. "

What this means to you: Parking in front of a residence is only allowed on a hard surface driveway (or street) meaning that vehicles are not to be parked in a yard. Parking in back and side yards is allowed on an all-weather surface, as long as the drivable surface leading from the front driveway (or street) to the back/side parking area is an all-weather surface as well.

Examples of an All-weather Surface include: 1) asphalt, 2) concrete, 3) compacted rock/crushed concrete, 4) brick paver stone. Certain requirements for minimum depth and base layer apply. Contact Haysville's Planning & Zoning Administrator at 316.529.5900 for additional details.

Facility Spotlight - Haysville Community Building

Located in W.W. Hays Historic Village Park, the Haysville Community Building is available to rent for family events, club meetings, luncheons and more. The cost of the rental is \$75.00 for Haysville residents or \$100.00 for non-residents, plus a refundable deposit of \$50.00. The building is ADA accessible, has tables and chairs to accommodate 80, and includes a full kitchen and ample parking.

License Requirements for Dogs In Haysville City Limits

All dogs at least six (6) months old residing within Haysville city limits are required to be vaccinated against rabies, and to be licensed with the city. Licenses are \$10 for sterilized dogs and \$20 for non-sterilized dogs, and can be purchased at City Hall with proof of vaccination. Contact the City Clerk's Office at 316.529.5900 with questions.
